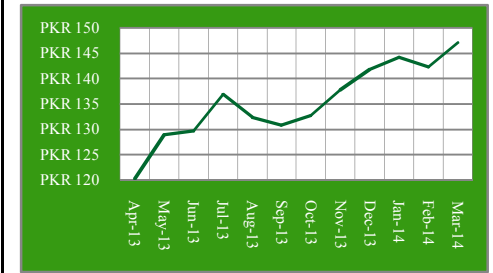
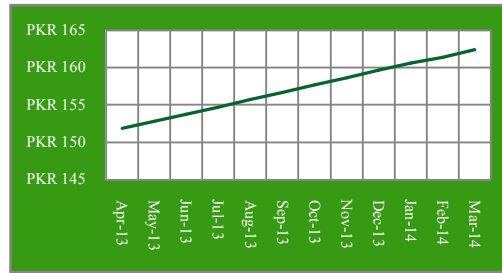
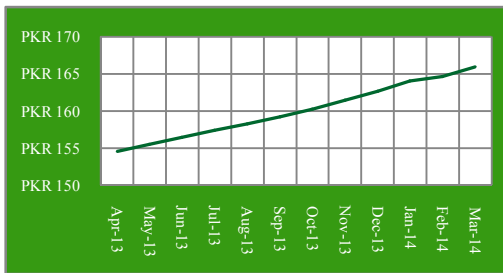

**Total Assets under Management - Rs. 576,073,781**

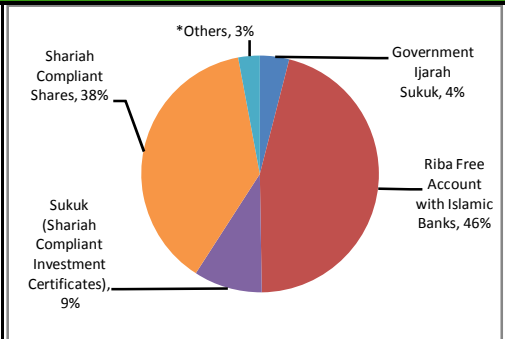
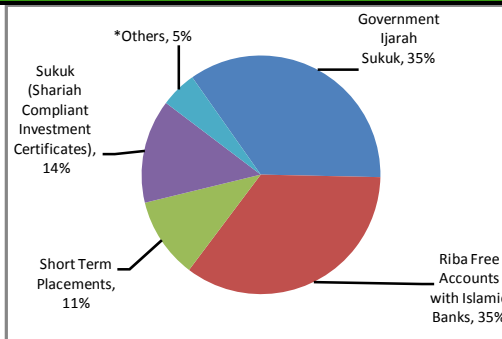
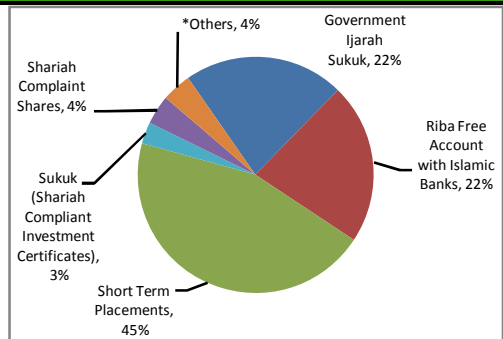
